Exemption Application Process: Persons seeking contiguous exemptions from payment of the parcel tax shall be granted an exemption upon satisfaction of the following requirements:

- (1) Timely completion (including the affidavit) and submission of this exemption application form with supporting documentation by the application deadline;
- (2) Furnishing written proof with the application that the parcels are contiguous;
- (3) Furnishing written proof with the application that the parcels are used solely for owner-occupied, single family residential purposes;
- (4) Furnishing written proof with the application that the parcels are held under identical ownership for which the exemption is being sought and they are the applicant's principal residence;
- (5) Furnishing written proof with the application that the parcels for which the exemption is being sought are located within District boundaries;

The parcels in question must be the primary residence of the applicant--rental and second properties are not eligible for contiguous tax exemption.

Exemption Application Deadline: This form, together with supporting documentation, must be completed for every year in which an exemption is sought. It must be delivered to the District Office no later than the close of business on June 30th, or the last business day immediately preceding that date, of the year for which the exemption is sought.
