<u>Exemption Application Process</u>: Persons seeking senior citizen exemptions from payment of the parcel tax shall be granted an exemption for the duration of each tax measure upon satisfaction of the following requirements:

- (1) Timely completion (including the affidavit) and submission of this exemption application form with supporting property tax documentation by the application deadline;
- (2) Furnishing written proof with the application that the applicant <u>turned age 65 before July 1st</u> of the year the application is made;
- (3) Furnishing written proof with the application that the property for which the exemption is being sought is the applicant's principal residence;
- (4) Furnishing written proof with the application that the <u>property</u> for which the exemption is being sought is located within District boundaries;

The property in question must be the primary residence of the applicant--rental and second properties are not eligible for senior citizen tax exemption.

Exemption Application Deadline: This form, together with supporting documentation, must be completed only once for the period of time that each tax measure is in effect. An individual who is approved for exemption need not apply again until a measure is renewed or replaced. The application must be delivered to the District Office no later than the close of business on June 30th, or the last business day immediately preceding that date, of the year for which the exemption will begin.
