

Schools Reopening Task Force A majority of those challenges were financial in nature, as I was tasked with eliminating a growing structural budget deficit and addressing aging facilities. Though it was a difficult and painful process, through reorganizations, early retirements, reductions in force, and other cost-cutting measures totaling over \$4.5 million, we were able to achieve a balanced budget.

## A Word from 2019-20 PTA Council President Dr. Michiko Lee

It is hard to believe we are halfway through the summer. We had a very unique year and the upcoming school year looks to be another one-of-a-kind year. I have the honor to serve on the School Re-opening Task Force (SRTF). I work alongside School Board members, District and school site administration, teachers, and parents. The SRTF serves as an advisory group to the School Board and met throughout the past weeks, planning for the start of school on August 12th.

The Instruction Team, led by Lettie Aranda and Diana Hang, are diligently planning what instruction will look like in the Fall, both in and out of the classroom. The Health and Safety Team, led by Dr. Danielle Dabbs and Zeina Daoud, are working to ensure that students, staff and families are prepared with health and safety protocols. Lisette Moggio leads the Operations team. They are working on a grant to fund financial needs related to implementing health and safety protocols. The Operations Team is getting our schools ready for students to safely return. The Social and Emotional Support Systems Team, led by Abigail Cabrera and Don Duranso, are looking at programs and training to support staff and students during this challenging time. The Family and Community Engagement Team, led by Nicolette Fuerst and myself, are working to engage families and the community in the re-opening planning process.

A survey was sent to families in mid-June. The results showed that 76% of families want their child back on campus in some form of school in the Fall; while 24% of families want their children to continue with distance-only learning. The SRTF is working diligently to address parent concerns expressed in the survey, such as social distancing, face coverings, grading, and attendance to name a few. Please keep an eye out for a second survey to come out mid-July.

Together we will navigate through these challenging times and come out stronger.



## **COVID-19 and School Re-Opening**

Under the direction of the Board of Education, the Superintendent, Executive Cabinet and Principals enlisted a cross-functional School Reopening Task Force (SRTF) to research and develop a comprehensive plan for SMUSD's safe reopening in August. The SRTF includes:

- District and school administrators, teachers, counselors & staff;
- Board members parents, students & community members;
- City Personnel -- Chief of Police and Fire Chief;
- Physicians, nurses and university professors;
- Bargaining unit representatives;
- PTA and SMSF leadership.



AB 77 -- SB 98

California SB98/AB77 does not allow for school districts to deliver pure distance learning unless a state or local health officer directs schools to close once again. The law also prohibits pure distance learning for individual students unless they are deemed "medically fragile, at-risk from in-person instruction, or quarantining to do exposure to COVID-19."

In order to design the highest quality and most equitable learning environment for ALL students in SMUSD, the SRTF was asked to:

- Develop a written plan for our schools & community:
- Identify resources, supplies and training.
- Provide direct support to schools and departments.
- Provide resources for student and staff social-emotional support.
- Provide resources and training to support a safe campus and work environment.
- Develop community education resources and communicate them effectively.
- Provide screening and/or testing for students and staff.
- Survey stakeholders (parents, students, faculty, and community) on reopening possibilities and priorities.

- 2. We are committed to supporting the individual needs of all students and families.
- We are committed to ensuring the health, safety and well-being of all students and staff.
- 4. We are committed to providing clear communication throughout all transitions to stakeholders
